SPORTS INSURANCE SCHEME SUMMARY

CERTIFICATE OF CURRENCY

We are able to forward a Certificate of insurance to your Academy, noting the period of insurance, the amount of cover and the Insurer. This will accommodate the requirements of Incorporation and or local Councils. Request a Certificate online by submitting a request from this website. SCOPE OF INSURANCE COVER

This summary has been prepared to assist you with all aspects of the Sports Insurance that your Academy holds. The insurance has been arranged with the intention of providing a basic level of coverage for all players, members and officials associated with the Academy. The scheme covers all registered participants, coaches, officials and voluntary workers whilst involved in training, playing, meetings or any official function/activity of within the Academy. Your policy benefits are summarised as follows:

NB: ALL CLAIM FORMS MUST BE RECEIVED BY THE UNDERWRITER WITHIN THIRTY (30) DAYS OF THE INJURY OCCURRING. ACCOUNTS AND REBATE STATEMENTS MAY BE SENT AT A LATER DATE.

PERSONAL ACCIDENT COVERAGE

SECTION 1. Death and Permanent Disability This section provides a lump sum benefit to insured's that suffer permanent injury or death. The maximum claimable under this section is \$100,000.00. Death cover is limited to \$10,000.00 for under 18 year olds. There is percentages payable for various levels of disability for example; Permanent Total Loss of Use of Hearing - One Ear \$ 25,000 - Both Ears \$75,000 ; Permanent loss of use of one arm \$35,000. A full list of the percentages is contained in the policy wording held by your Academy.

SECTION 2. Medical Coverage

This section provides 80% Reimbursement of any Non-Medicare expenses up to a maximum limit of \$3,000.00 per injury. There is a \$50.00 excess applicable to each claim lodged with the underwriter. Coverage is for any Non Medicare expenses incurred within 12 months from the date

of injury. Non-Medicare expenses are those costs that are non-recoverable (in any part) through Medicare. These expenses include dental, physiotherapy, chiropractic, ambulance, private hospital accommodation and, private hospital theatre fees. The expenses **not** able to be claimed through this section or better known as the Medicare Gap include;

- a) The amount between the doctor's fee and the money you receive back from Medicare.
- b) The amount between the Surgeons bill and the money you receive back from Medicare
- c) The amount between the Anesthetists bill and the money you receive back from Medicare
- d) X-Ray costs.

ALL ACCOUNTS MUST BE PAID BY THE PLAYER BEFORE SUBMITTING TO THE INSURANCE COMPANY. PLEASE NOTE THAT ALL CLAIMS UNDER THIS SECTION MUST INCLUDE A DOCTORS REFERRAL FOR THE SERVICE BEING CLAIMED. CLAIMANTS WHO CARRY PRIVATE HEALTH INSURANCE MUST SUBMIT ALL BILLS TO THEIR HEALTH FUND INITIALLY AND THEN FORWARD A COPY OF THE REBATE STATEMENT TO THE INSURER FOR COMPENSATION.

SECTION 3. Loss of Income

This section provides an income replacement to insured's who suffer an injury and are temporarily totally disabled from performing their usual occupation. The benefit is 80% of your usual weekly salary or \$250.00 per week whichever is the lessor. There is an excess period of 2-week (14 days) on your policy. The benefit is claimable for 52 weeks from the date of injury. To make a claim under this section the player **must**;

- a) Provide a Doctor's Certificate for the period off work.
- b) Provide a letter from the claimants employer detailing usual gross wage, time expected off work, and whether the claimant is receiving sick or holiday pay.
- c) Have the Attending Physicians Statement completed and forwarded to the insurance company. If a claimant is self-employed, these questions must be completed on a statutory declaration.

STUDENT ASSISTANCE BENEFIT

The insurer will reimburse 80% of expenses up to \$250 per week for every week of continuous temporary total disability. There is an excess period of 14 days and the benefit is payable for 52 weeks. Expenses claimable under this section include Home Tutor, writer etc. The benefits restricted to full-time students under the age of 20 years.

HOME HELP EXPENSES

The insurer will reimburse 80% of expenses incurred up to \$250 per week for every week of continuous temporary disability. There is an excess period of 14 days and the benefit is payable for 52 weeks. Expenses claimable under this section include "Dial an Angel" services, domestic help companies, eg bed making, meal preparation etc.

NB: ALL PRE-EXISTING CONDITIONS ARE EXCLUDED BY THIS POLICY

PUBLIC LIABILITY COVERAGE

Your club and its members are insured for any claims arising from negligence in respect of bodily injury or property damage, that happen during the period of insurance and caused by an occurrence in connection with your sport. The coverage provided is for \$20,000,000 any one event and policy period.

Coverage extends to include; · Tenants Liability · Property Owners Liability · Products Liability · Member to Member liability excluding level 4 sports such as rugby league and other contact sports · Medical Aid Liability · Car Parking Liability · Cross Liabilities

Cover for this section is worldwide excluding the United States or Canada and any claim brought against the insured in any country outside Australia.
A full list of the policy exclusions is contained in the Insurer wording.

PROFESSIONAL INDEMNITY COVERAGE

All accredited coaches and game officials are insured for claims arising from breach of professional duty arising from negligent acts, errors or omissions in connection with the sport. The coverage provided is for \$5,000,000 in the aggregate. Coverage for this section is worldwide excluding the United States and Canada and any claim brought against the insured outside Australia.

NB: All claims under this section of the policy must be immediately notified to the insurer during the period of insurance.

TRAVEL INSURANCE

The Sports Policy provides worldwide Personal Accident protection. However, should your Academy or team be travelling overseas to compete in Tournaments/Carnivals etc, please contact our office and we will arrange appropriate insurance coverage that includes cover for training and playing of sport. Any inquiries or questions regarding this cover should be directed through your association secretary.

"TOP UP" COVER

As mentioned previously, the cover provided under your scheme is not "all encompassing". However, DHB Insurance Brokers is able to arrange additional "Top Up" cover for the various sections of the policy for either sports or individual players. The two main areas that can be "Topped Up" are the Loss of Income and Medical sections.

DIRECTORS & OFFICERS LIABILITY INSURANCE

Also included in the insurances arranged within the Academy is a protection policy for all the Directors, officers and committee members of the Academy. This provides personal protection (subject to policy conditions) for any claim against them in the event of a wrong doing whilst carrying out their duties as a Director, officer or committee member.
